2) Electrical system will be separated in 2 parts

a. For lighting

b. For equipment

which are not able to connect to each other for safety reason. The electrical current AC220 V. Single Phase 50Hz and 380 V. Three Phases 50Hz. The voltage is slightly vary approximately 10% and for safety protection to exhibits, the exhibitor should secure the proper equipment to control the voltage before connection. Every power point must order with the FORM only otherwise, the official electrical contractor will not be able to render service.

Remark

- 1) Cancellation during **8 July – 8 August 2016**, exhibitor will receive 50% refund and if later than that NO refund.
- 2) The exhibitors must submit the Electricity Form to Kingsmen C.M.T.I. PLC. otherwise, we will install as appropriated and the exhibitors must take care all of the payment in case to change position or re-installation.
- 3) One socket must be used for one exhibit at a time. Multi-point connection is not allowed to prevent risk of power overload.
- 4) The standard supply is 110V, 220V or 380V with approximately 10% voltage fluctuation. For the safety of your equipment, exhibitors with very sensitive equipment are advised to bring their own stabilizer to cater for voltage fluctuation.
- 5) A surcharge of 100% of electrical equipment will be added if you require 24-hour operating services.
- 6) Any illegal connection or adaptation be found the exhibitors have to be fined 20 times following the price in the manual.
- 7) Any equipment re-location fee is 300 baht per point and circuit breaker re-location fee is 1,000 baht per point (exclusive of 7% VAT).
- 8) Please note that 7%VAT is applicable in Thailand and must be included in your payment. The wire transfer fee for payment from overseas shall be the customer's responsibility.
