



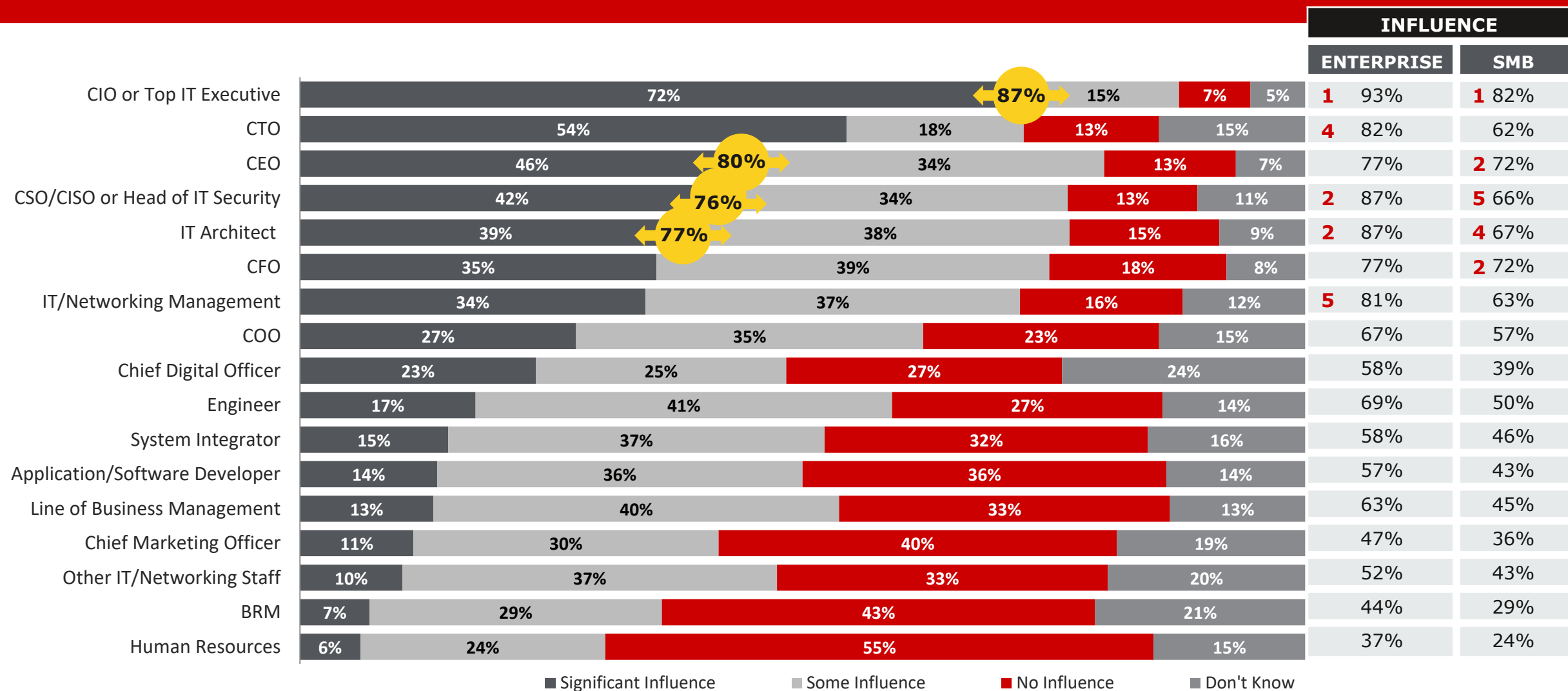

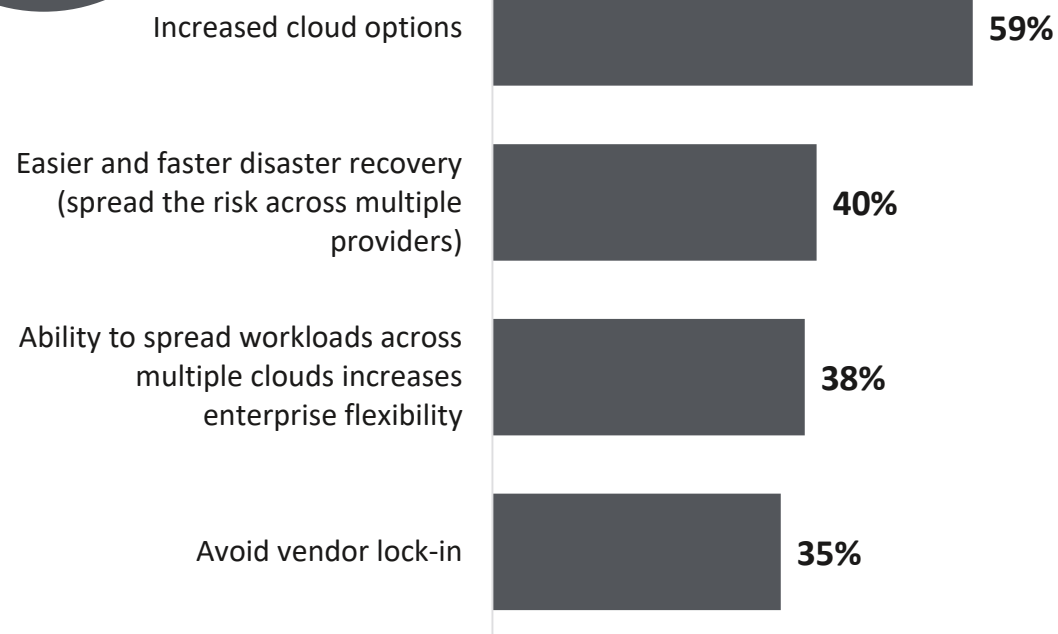
Q. How influential are the following groups/individuals during the cloud computing purchase process?

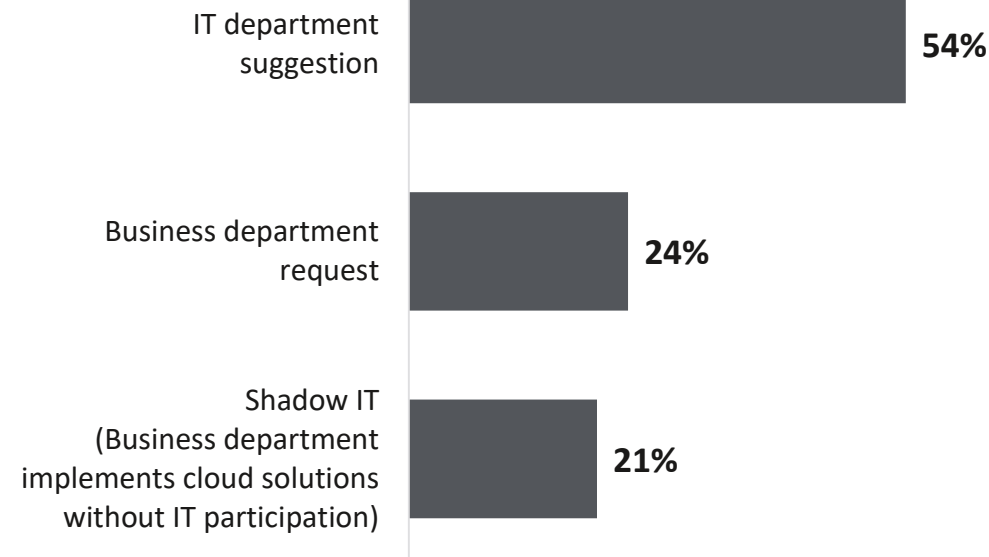

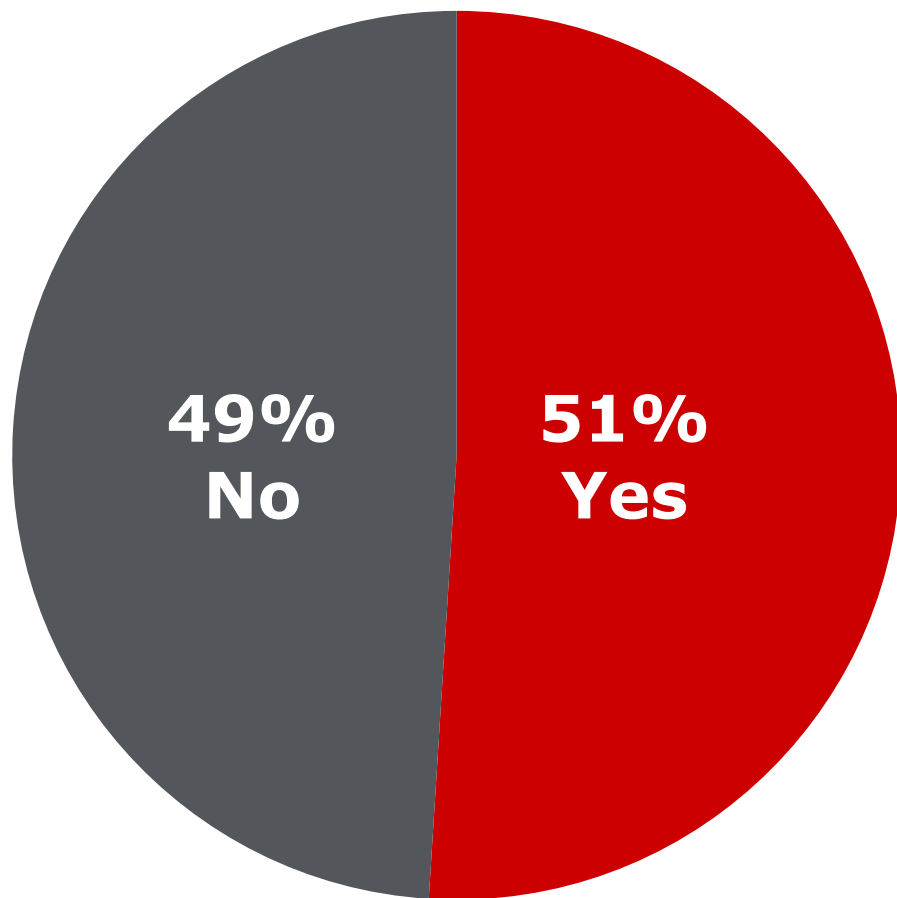

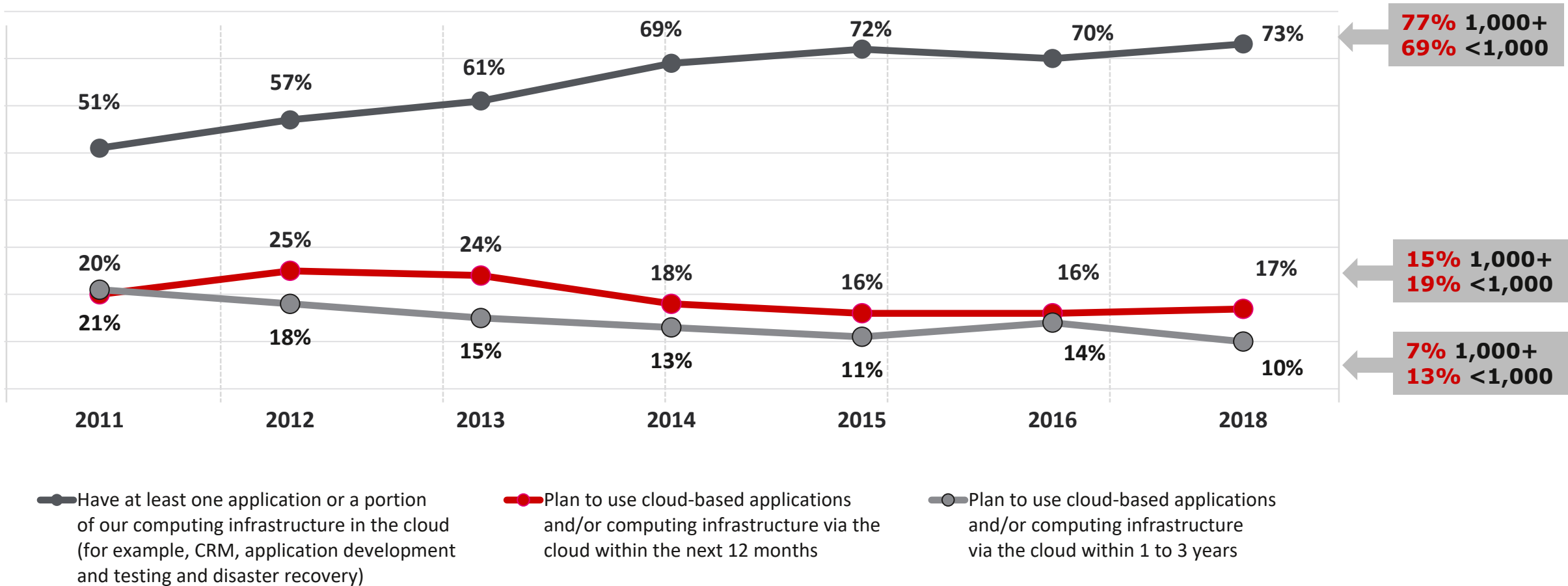

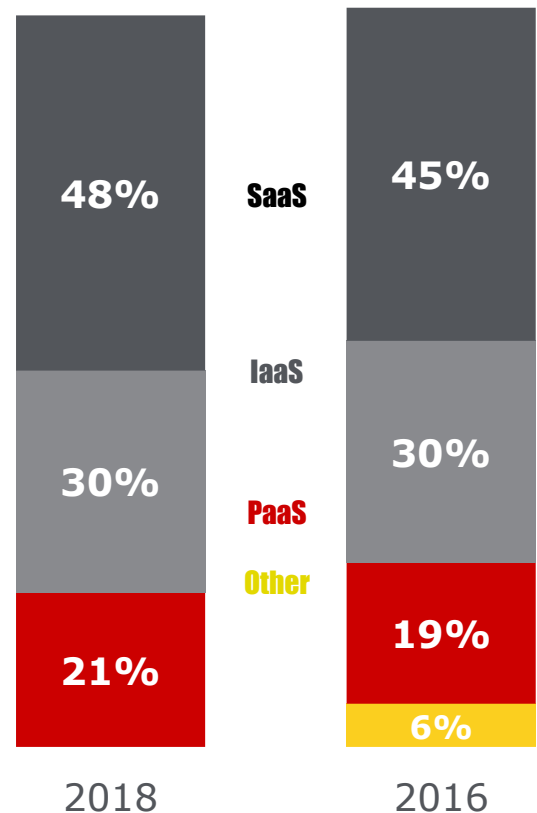
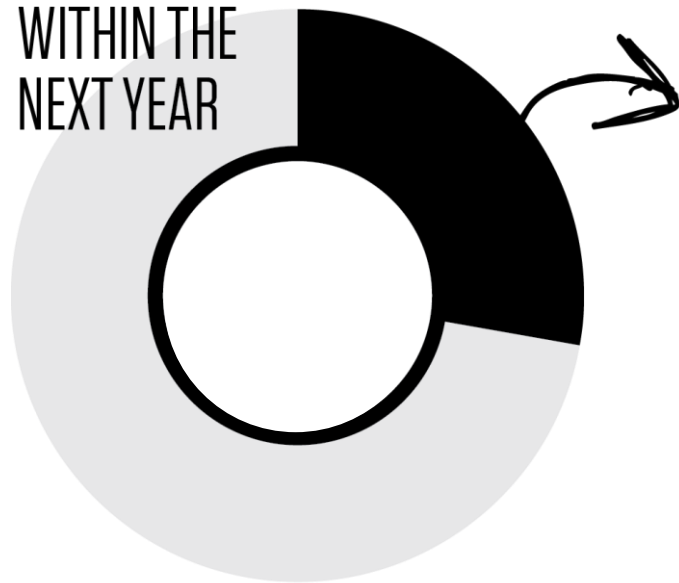

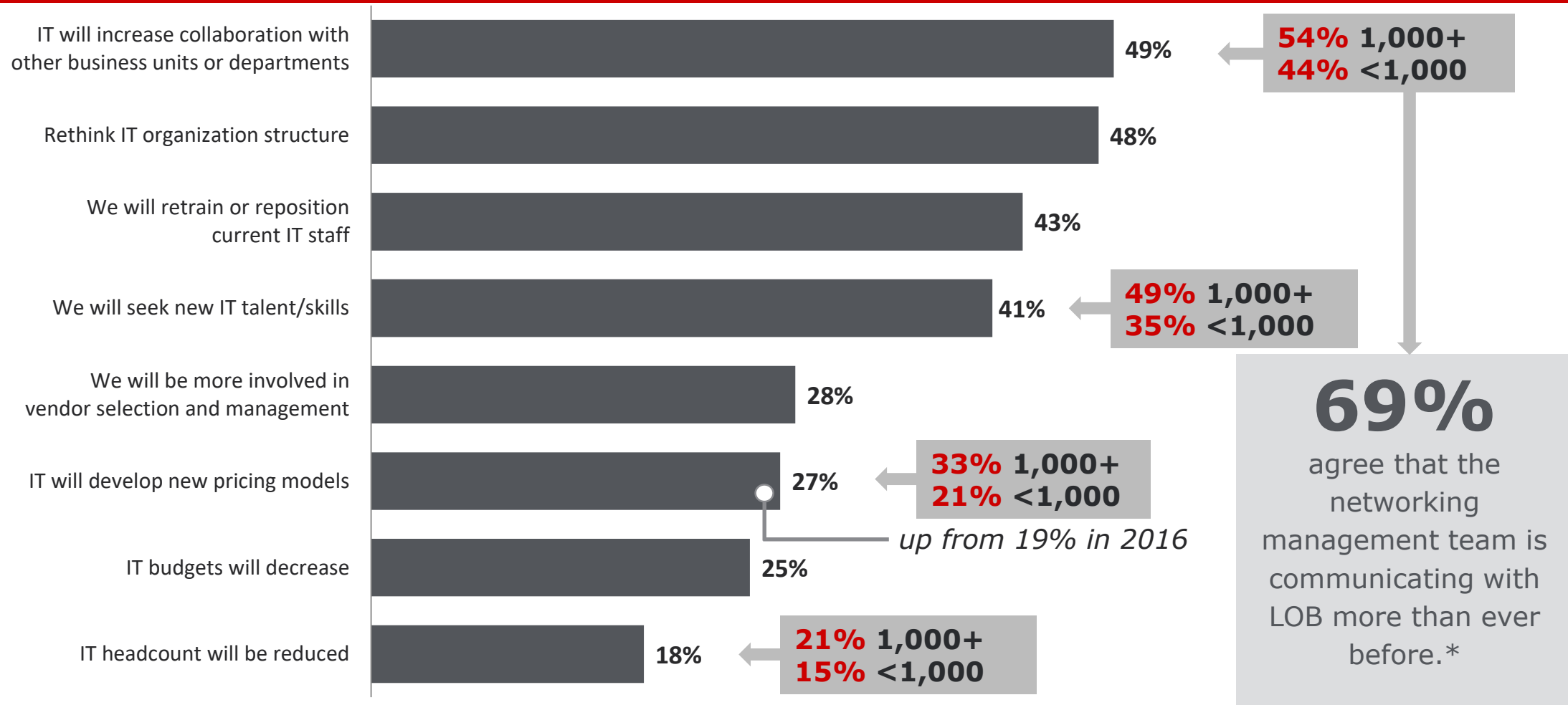

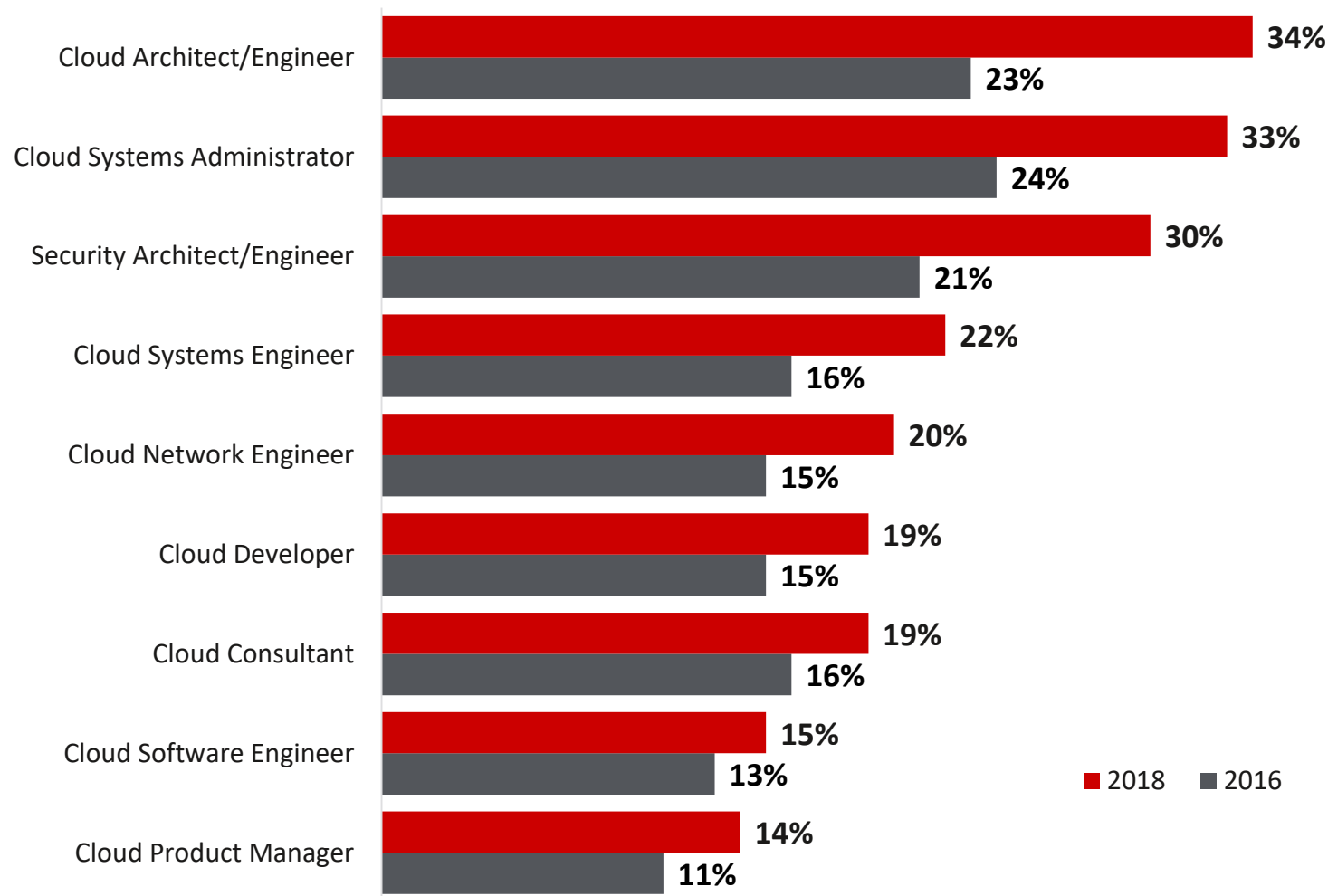

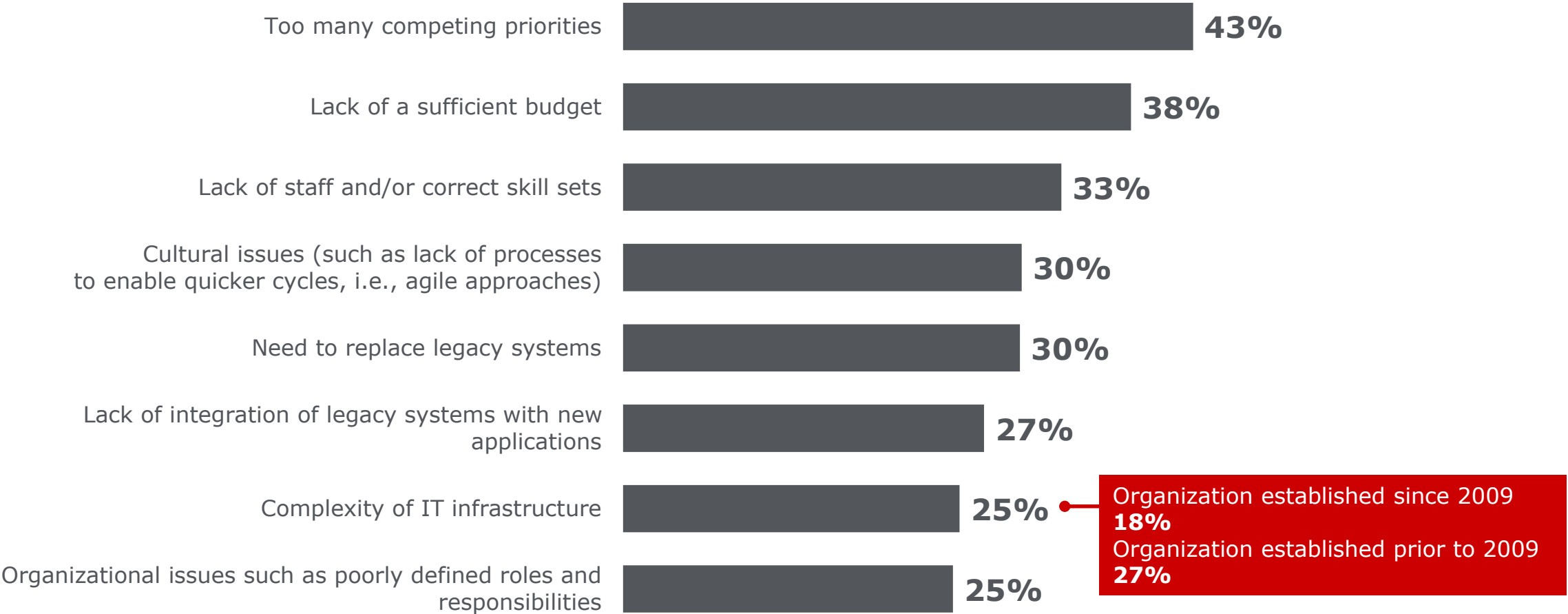
