

Key Legal Issues of Telemedicine



Licensing / Registration of Healthcare Professionals


Questions to be answered:

• Are healthcare professionals accredited to deliver services at distance?

 Is their accreditation valid at their registration location?

Is their accreditation valid at the point of delivery?






Liability Issues and Product Safety

Questions to be answered:

• Where the systems or devices used in the application subject to rules of certification (e.g. Medical Device Directive, CE Certification)?

 If yes, were all devices or systems intended for use in the application certified or did substitutions have to be made?





Healthcare Professional Liability

Questions to be answered:


• Does the accreditation regulation of each actor of the system envisage liability problems?

Is professional liability insured?

• Who is responsible for what in the system (think about every event)?

• Is there any element of patient liability involved?






Information Governance (1)

Issues linked to patient identifiable information access and transfer are:

- Data processing.
- Access rights of healthcare professionals.
- Responsibilities of data controllers and processors.
- Free flows of personal (medical) data within telemedicine applications.





Information Governance (2) Patients' Rights The rights of the patients are: Right to be informed. Right to access their data. Right to rectify their data. Right to object the processing.

High standards appropriate to the data type



- Re-use of clinical data






Collection of Information on Legal Aspects


