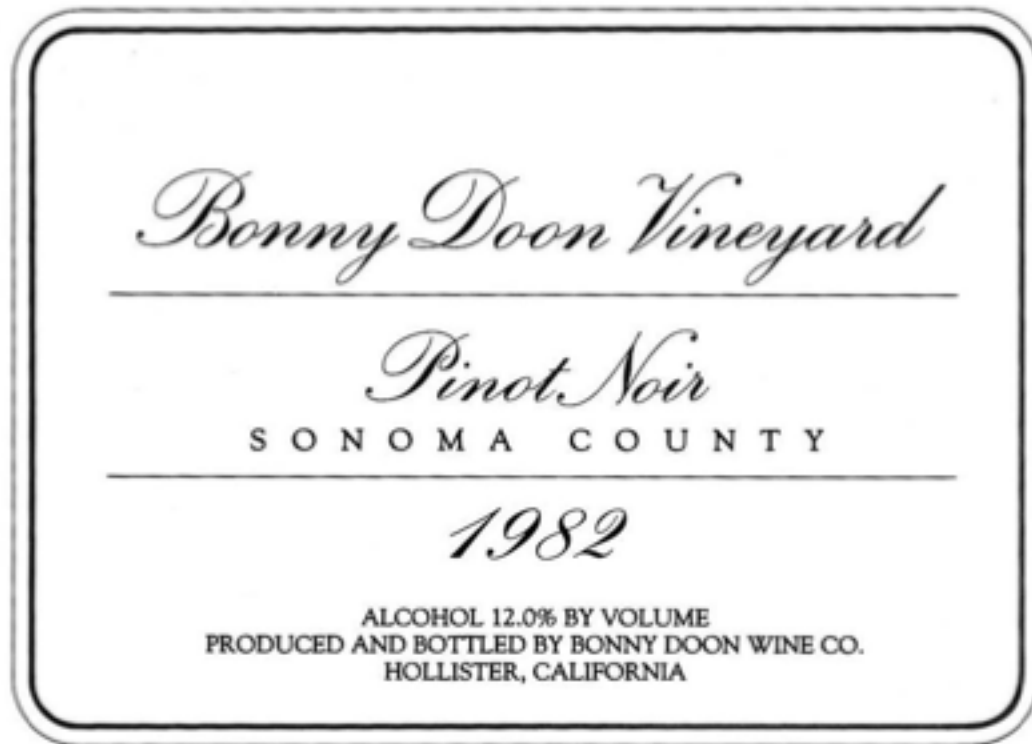

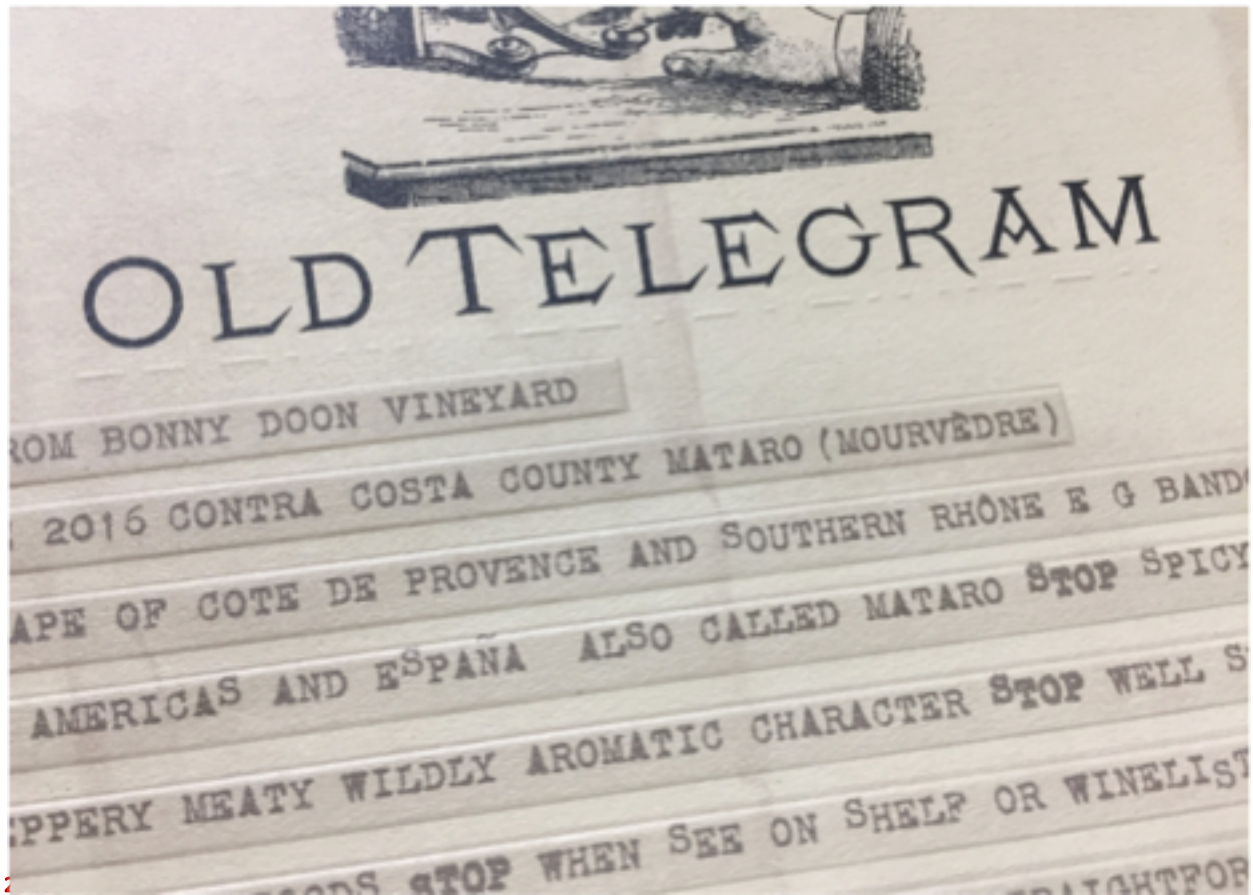

For their time these laws were monumental. Their efficiency is well judged from their almost unchanged existence more than sixty years later, and they now form the basis of the national laws of *Appellation d'Origine*, themselves only adopted in 1936.

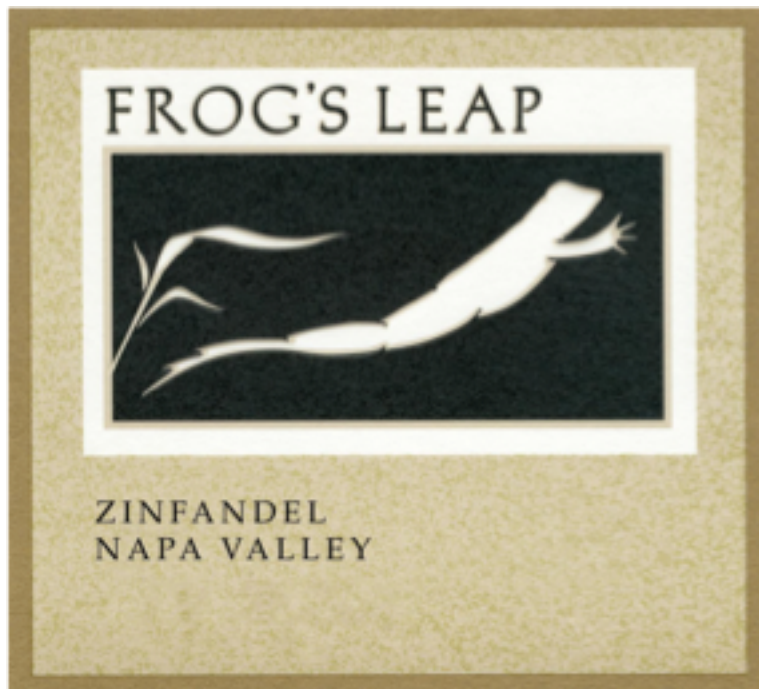
Such exemplary vigilance over their wine was repeated by the *vignerons* in a municipal decree of 1954. Flying saucers had just come to people's attention, and the village decree firmly stated:

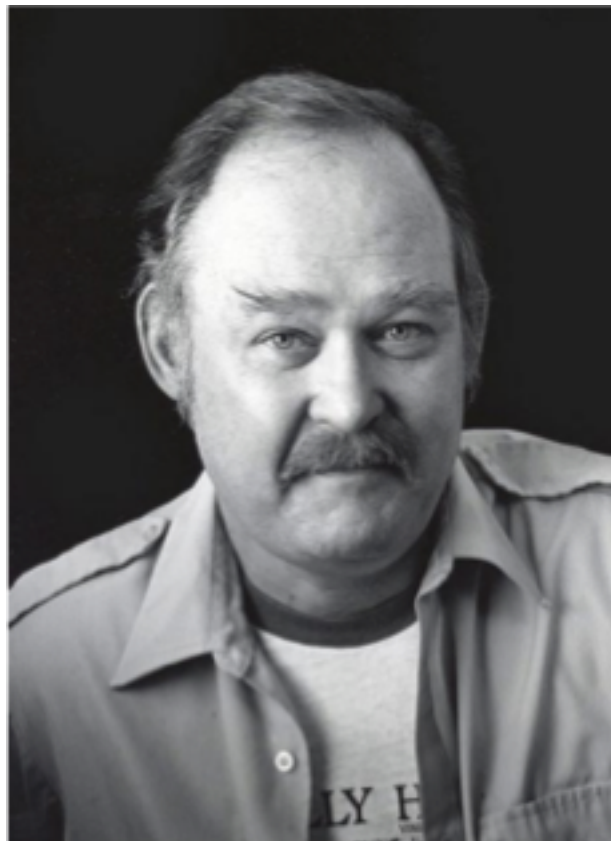
Article 1. The flying overhead, landing and taking off of aeronautical machines called 'flying saucers' or 'flying cigars', of whatever nationality they may be, is strictly forbidden on the territory of the commune of Châteauneuf-du-Pape.

Article 2. Any aeronautical machine—'flying saucer' or 'flying cigar'—that lands on the territory of the commune will be immediately taken off to the pound.

Châteauneuf-du-Pape has never been a large village and today

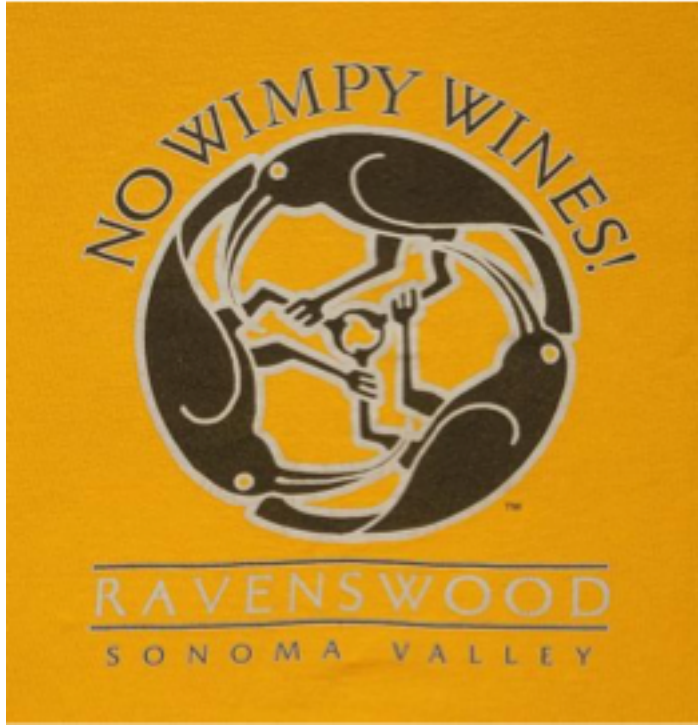






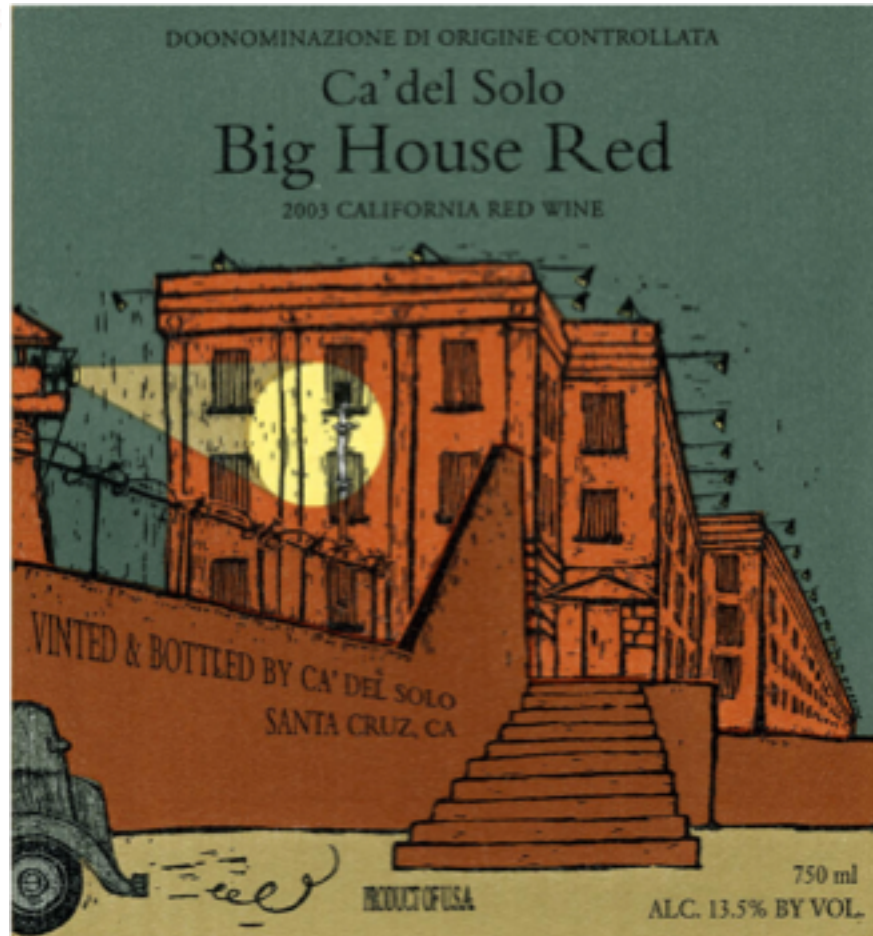
