Mike has a wealth of state experience having held a series of positions in Pennsylvania state and local government, including acting secretary of the Pennsylvania Department of Public Welfare (DPW) from 2007-2010. In this role, Mike led the delivery of state sponsored health and human service programs serving more than 2 million low-income Pennsylvanians, and helped lead health care reform efforts in the Commonwealth, including implementation of major policy and funding initiatives such as health homes, improved integration of health care services for dual eligibles, and health information technology.

Most recently, Mike was a Managing Principal at Health Management Associates (HMA), focusing on helping states to improve systems of care for Medicaid beneficiaries with multiple chronic conditions. In this role he was involved with the Innovation Accelerator Program (IAP) work that assists states in developing strategies to better serve beneficiaries with complex needs and high costs. At HMA, he also led a technical assistance team for a National Governors' Association Policy Academy devoted to improving care



for this population, and has co-authored several papers published by the Kaiser Commission on Medicaid and the Uninsured, including papers on state implementation of health homes authorized by the ACA.

Prior to that, he was CEO of Iowa's Blank Park Zoo, President and CEO of Rich Heritage, Inc.—a national marketing and television production company producing shows for HBO, ESPN, Comcast, etc.— and Vice President of Marketing for Heritage Communications, Inc. He has won numerous entrepreneur awards in television production and marketing, has a BS in Speech from Iowa State University, and is a member of the ISU Board of Governors. You may have seen him on national television, ranging from hosting *Starz!* to making a panel guest appearance on *Johnny Carson's Tonight Show*. In the late 1990's, he served as co-host of the *Bill Riley State Fair Talent Search*.

As an Iowa entrepreneur in the 1990's, Terry developed four other companies, along with Rich Heritage, Inc., which include: radio station KBBM, US Digital Video, Newsletter Ease, and the World Championship Socker League, LLC.

As CEO of the Iowa Lottery, Terry leads Iowa's \$250 million enterprise, which generates nearly \$60 million yearly to the state's general fund and to the Iowa Veteran's Trust Fund. He also serves on the executive board of Powerball and the new Multi-State Lottery game being developed for the United States.
