Frontier markets have particular risks such as geopolitical unrest, inadequate institutions, currency instability, lack of transparency and illiquidity. But frontier markets also offer tremendous growth prospects. There is a tendency to overstate challenges in frontier markets because the areas are new to most investors. Nonetheless, it is necessary to be aware of the risks, and to have a strategy for managing them. Frontier market analysts discuss the pitfalls investors and businesses need to consider and weigh against the potential returns.
