AGC AT A GLANCE





AGC AT A GLANCE

- Federation with 92 chapters
- Represents the entire industry
- 67 FTEs/2 PT
 - Avg. tenure = 10.5 years
 - Avg. senior staff tenure = 19.5 years
 - 2 significant retirements at end of year
 - COO Dave Lukens (31 years)
 - Chris Monek (40 years)





AGC FINANCES

- Expected 2017 revenue: \$21.03 M
 - Chapter dues = 45.2%
 - Mgt conferences = 12%
 - Product line/Credentialing = 11%
 - Convention = 10%
 - Sponsorships/affinity = 16%
- Expected 2017 expenses: \$20.88 M
 - Salaries/benefits = 50.25%
 - Non-dues expenses = 12.4%
 - Convention = 9%
 - Meetings = 8%

TRUMP ADMINISTRATION

- Being run like a bad family owned small business
 - Autocratic leader; family members with broad authority
 - Undermines/humiliates senior team
 - Preibus: "I was given 70% of the authority and 100% of the accountability"
 - Kushner has lead over Tillerson on major foreign policy issues
 - Sessions should not have recused himself on Russia probe
 - Difficult to recruit for senior positions (lobby ban)
 - No clear direction from the top
 - No message discipline: "infrastructure press conference"
 - Lack of delegation
 - Reviewing applicants for 3rd tier Department jobs





PACE OF ADMINISTRATION APPOINTMENTS

- While Senate Dems have used all options under the rules to delay confirmations, there is plenty of blame to go round
- 600 non-judicial positions need Senate confirmation
- As of 9/14:
 - 306 no nominee named
 - 15 announced nominees not formally submitted
 - 158 formally nominated
 - 121 confirmed
- Lack of political appointees hinders policy development and execution and our opportunities to make our case





REACHING A DEAL IS THE OBJECTIVE....

- Agreement with "Chuck & Nancy" on hurricane relief, debt ceiling
- Reaction to frustration with GOP leaders
- Not well planned on downside risk
 - Requiring another vote on debt ceiling in December or soon thereafter
- Demonstrates Trump's lack of political ideology
- Is he culturally and personally more comfortable with Dems?
- Does this put heat on House Freedom Caucus to get good deal not their deal on legislation?
- Does Trump force bipartisan discussion on tax reform, infrastructure?





AGC LEGISLATIVE AGENDA





BIG WEEK in DC

- Need budget resolution by 9/30 to start reconciliation process
 - Avoid Senate filibuster
 - Vehicle for tax reform
 - But 10 year window for tax cuts, not permanent
- House Ways and Means meeting today
- House "retreat" on Wednesday
- Senate taking up Graham-Cassidy health care repeal bill
 - Is there 50 votes?
 - Can House GOP find 218 votes?





AGC TAX REFORM OBJECTIVES

- Lower the rates
 - Bipartisan recognition that corporate rates make US firms less competitive
 - AGC pushing for "S" corp parity
- Simplify the tax code
- Eliminate barriers to economic growth
 - Repeal the death tax
 - Eliminate the Alternative Minimum Tax
 - Reduce capital gains, dividend and interest income taxes





AGC TAX REFORM OBJECTIVES

- Protect existing infrastructure financing programs
 - Muni bonds
 - Private activity bonds
- Fix the Highway Trust Fund
 - Infusion needed by 2020
 - Does Congress solve a problem before a deadline?
 - Multiple ways to do it
 - Repatriation of foreign profits
 - Gas tax
 - Customs fees, excise taxes
 - Other?
- Funding for Trump Infrastructure Plan (mixed signals)





TRUMP INFRASTRUCTURE PLAN

- Quietly unveiled in budget/infrastructure broadly defined
- Components (still a moving target)
 - Making targeted federal investments (\$200 B/10 years)
 - \$15 B for transformative projects
 - \$25 B for rural projects
 - Encouraging self-help for local & state projects
 - Reform the permitting process from 10 years to 2 years (AGC chart)
- Current federal expenditures = \$120 B/year





POLITICS OF THE PLAN

- Trump: "Infrastructure should be easy!"
- Really?????
 - How do you fund it?
 - What are the benefits for GOP districts?
 - Dems represent urban areas where PPPs can deliver revenue
 - How many GOP members got reelected on spending more \$ on infrastructure?
 - Commerce Dept. infrastructure panel disbanded
 - Dems so far have demonstrated they aren't going to lift a finger to help
 - Even more so if tax reform passes on party lines





INFRASTRUCTURE WORKING GROUP

- Broad-based business/labor/governmental entity coalition
 - Founded by AGC and NAM
 - Objective to get a bigger pie/others can try to get their slice
 - Over 70 groups at first meeting in May
 - For now, info exchange
 - To grow into PR support for Congressional action
 - Need to be made permanent

REGULATORY ROLLBACK SUCCESS

- Final Rules Repealed
 - Blacklisting
 - OSHA Volks Rule (Injury & Illness Recordkeeping SOL)
- Final Rules Delayed
 - Silica (9/23/17) plus one month of "soft" performance
 - OSHA Electronic Injury & Illness Recordkeeping (no new date suggested for compliance)
 - Joint employer doctrine
- Back to the drawing board
 - EPA "waters of the US"

- Comprehensive workforce plan
 - Immigration reform
- Clarify Trump E.O. on apprenticeship programs
- PR activities to highlight challenges/promote solutions

- Working with Administration to tie workforce to infrastructure plan
- Promoting chapter best practices and ideas





AGC MEMBER DISCOUNT PROGRAMS

- Partnerships with 15 firms on industry-essential products/services
- Members collectively save +\$10 M annually
- GM, Ford, Fiat Chrysler
 - 10,000 vehicles purchased
 - Avg. savings of \$750
- Fedex: \$6 M packages through program = \$1 M in member savings
- Fuel cards: participating users see avg. of \$975 in savings

AGC AS THE INDUSTRY LEADER

- CONSENSUS DOCS
- BIM Forum
- AGC Learning (34 chapters as testing centers)
 - Lean Construction Education Program
 - 3500 units taken so far this year
 - 538 have earned CM-Lean credential
 - BIM Education Program
 - Over 1000 units taken this year
 - 713 hold CM-BIM credential
 - AGC Webinars: 54 this year/2121 participants
 - Silica last week had nearly 600 participants
