

## OFFICIAL RULES

### UConn NYC Alumni Network Football Jersey Giveaway Contest

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

#### 1. Eligibility:

The “UConn NYC Alumni Network Football Jersey Giveaway Contest” (“Contest”) is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of University of Connecticut, University of Connecticut Foundation, Inc. and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members, whether related or not, of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

#### 2. Sponsor:

The Contest is sponsored and promoted by The University of Connecticut Foundation, Inc. (“Sponsor”), located at 2390 Alumni Drive, Unit 3206, Storrs, Connecticut 06269-3206.

#### 3. Agreement to Official Rules:

Participation in the Contest constitutes entrants full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

#### 4. Contest Period:

The Contest begins September 10<sup>th</sup> 2016 and ends November 21<sup>st</sup> 2016 (“Contest Period”). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods: (i) submit your completed entry form to the Sponsor’s designated volunteers Marcus Perkal or Andrew Taylor (NYC Alumni Advisory Committee) at one of the UConn Game Watch events listed in Section 5 below ; (ii) email a scanned copy of the completed entry form to [jproulx@foundation.uconn.edu](mailto:jproulx@foundation.uconn.edu) (entry forms must be received on or before Monday, November 21, 2016); or (iii) mail the completed entry form via U.S. mail (postmarked on or before Monday, November 21, 2016) to Joshua Proulx, UConn Foundation Office of Alumni Relations, 2384 Alumni Dr., Unit 3053, Storrs, CT 06269.

#### 5. How to Enter:

To enter you must be otherwise eligible in accordance with these Official Rules and your completed entry must be submitted during the Contest Period. One Entry is permitted per person. To enter, you must (i) attend at least three (3) of the five (5) UConn Game Watch events

conducted by the UConn Foundation Alumni Office that are scheduled to take place at Van Diemens Bar and Kitchen located at 383 3rd Ave, New York, NY on September 10, 2016, September 29, 2016, October 15, 2016, October 29, 2016 and November 19, 2016, and (ii) you must have your entry form stamped each time you attend such UConn Game Watch events by the Sponsor's designated volunteers. All entries become the property of Sponsor and will not be acknowledged or returned. Entries must be completed and submitted by an individual, eligible entrant only; no group entries allowed.

#### 6. Prize Drawing:

On or about November 22, 2016 the Sponsor or its designee will select three (3) potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the total number of eligible entries received. The Sponsor will attempt to notify the potential winners via email or private message on Facebook, Twitter, or Instagram on or about December 1, 2016. If the potential winners cannot be contacted within three (3) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

#### 7. Winner Notification:

The potential winners will be notified by email or private message on Facebook, Twitter, or Instagram. The winners (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance, Liability and Publicity Release ("Declaration") within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. If the potential winner is at least 18 but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize in the name of his/her parent or legal guardian, who will be required to sign the Declaration on the potential winner behalf and fulfill any other requirements imposed on winner set forth herein. Potential winners must continue to comply with all terms and conditions of these Official Rules and winning are contingent upon fulfilling all requirements. In the event that a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded. Prizes will be fulfilled approximately 7-10 days after the conclusion of the Contest. Winners will be announced on UConn NYC Alumni Facebook and Twitter.

#### 8. Prize:

Three (3) individual prize winners will each receive a UConn Nike Football Jersey. Major restrictions may apply to the use, availability or receipt of the prize. Winners are solely responsible for all applicable taxes and tax filings.

#### 9. General Conditions:

In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Contest is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may, in its sole discretion, either (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Contest and, in the event of termination, award the prizes at random from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

#### 10. Release and Limitations of Liability:

By participating in the Contest, entrants agree to release and hold harmless the Sponsor, the University of Connecticut, and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Contest, and each of their respective officers, directors, trustees, employees, shareholders, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Contest or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) any technical errors associated with the Contest, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, wireless service provider, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone, cellular tower or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Contest; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) application downloads, (e) any other errors or problems in connection with the Contest, including, without limitation, errors that may occur in the administration of the Contest, the announcement of the winner, the cancellation or postponement of the event, if applicable, the incorrect downloading of the application the processing of entries application downloads or in any Contest-related materials; or (f) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Contest or acceptance, receipt or misuse of the prize (including any travel or activity related thereto). Entrant further agrees that in any cause of action, the Released Parties liability will be limited to the cost of entering and participating in the Contest, and in no event shall the entrant be entitled to receive attorney's fees. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest. direct, or indirect damages. Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Connecticut. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants rights and obligations, or the rights and obligations of the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of Connecticut, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than Connecticut.

#### 12. Privacy:

#### 13. Winner List:
