

- DoD Farm to School




USDA Foods Ordering Cycle

- Free Storage
 - 45 days
- Short term
 - 46-179 days
- Long Term
 - 180 + days

Private Storage Inventory Losses

- Form 1638- Report of Loss of USDA Foods
- TDA determines responsibility and liability
- CE reimbursed or product replaced





Delivery Order Form

- Contracting Entities > Delivery Orders CE > Open Orders
- Confirm CE Name
- Create new Delivery Order



Delivery Order Form

- Modify existing orders
 - At least 2 days prior to delivery
- Surplus
 - Utilizes entitlement



Short Shelf Life Items

- Examples
 - String Cheese
 - Yogurt
 - FTS
- Added to orders if CE does not add
- Contact TDA if you cannot accept





Inventory Management

- Verify product dating
- FIFO or FEFO
- Monitor inventory in storage
- Contact TDA for any inventory concerns





Delivery Schedule

- Arranged with warehouses
- First delivery: per case rate
- Subsequent deliveries
 - <100 miles 20 case min
 - >100 miles 40 case min



Delivery Verification

- Count and inspect orders
- Note discrepancies on BOL
- Overages, shortages, damages
- BOLs and invoices



Losses After Delivery

- Damages or quality issues
- Report to TDA



Delivery Order Invoices

- Contracting Entities > Invoices
- Click invoice number
- If printing select pdf format



Annual Inventory Count

- Physical count at each warehouse
- Reconcile inventory
- Shortages



Customer Service Survey

- Annual survey to get feedback on warehouses
- Responses are confidential
- Results shared with warehouses



2019 Customer Service Survey

- Palletization
- Late deliveries
- Delivery windows
- Drop locations
- Invoicing
- Shortages



Complaint Process

- Warehouse complaints
 - Contact warehouse
 - Unresolved issues contact TDA
- USDA Foods complaints
 - Complete complaint form and submit to TDA



Policy Update

- 7 CFR Part 250
- Distributors cannot commingle Commercial and FFS
