Canada: Becoming a Sustainable Energy Superpower

Industry Leaders' 24 hour meeting in Sarnia on May 5 and 6 will debate alternative pathways for capturing value from Canada's energy resources. The pathway chosen will have enormous impact on jobs and wealth generation for decades to come.

"Be it resolved that provincial and federal governments in Canada should take pro-active measures to encourage greater refining and processing of Canada's petroleum resources within Canada than would occur through private market decisions alone."

The issues involved were defined in the Canadian Academy of Engineering's book 'Canada: Becoming a Sustainable Energy Superpower', documenting key findings in the Academy's ten-year analysis of Canada's energy future.

It will be argued that a pivotal first step will be the construction of a \$10 billion refining complex in Sarnia/Lambton using the latest technology in environmental protection. An essential feature will be a dramatic expansion in Canada's manufacturing industry to capture the almost unlimited opportunities in the supply of equipment needed by our energy industries, now largely provided though imports.

Several years ago, a group of constituents met with me to discuss working towards locating a new refinery in our community. This proposal was brought forward by a group of former industry stakeholders who wanted to work together to bring this opportunity to Sarnia-Lambton.

The proponents, including Dr.'s Clem Bowman and Walter Petryschuk, have put much effort into building the case for a new refinery project in our community and have taken all opportunities possible to advocate towards this objective. Working in conjunction with a growing group of community partners and supporters, this idea grew into the Sarnia-Lambton Advanced Bitumen Energy Refinery project, more commonly known now as "the Saber Project."

The fact remains that it has been decades since a new refinery was built in Ontario – something that the Saber project would rectify. It is a simple fact that Sarnia-Lambton has the quintessential ingredients required for such a proposal—we have the experienced workforce, we have the pipeline capacity in and out of the community, and we have the expertise in our business community to steer such a large-scale project towards prosperity and overall success.

I would also add that we have elected Officials who understand the importance of the oil and gas industry in Sarnia-Lambton to not just our localized community, but to the entire nation as well.

This is important, because it will take the commitment and focus of all the afore-mentioned groups to work in solidarity to ensure that this project becomes a reality.

Already, we know the tangibles for success are present. The end result will be an achievement quite worthy of consideration: billions of dollars in direct investment into Sarnia-Lambton, with spillover across the entire South West Ontario region as the industrial impact of such a large-scale project becomes reality. This would equal thousands of jobs, ensure long-term and well-paying employment opportunities across the region, and give Canada a foot-in on the value-added side of domestic energy production.

I would like to take this opportunity to thank the numerous proponents behind the Saber Project who have put in so much time and energy to try to move this proposal forward, and those in attendance today. I hope that you are able to enjoy the Conference in our beautiful community of Sarnia-Lambton.
