IMPORTANT CONDITIONS AND REGULATIONS

1. USE CARE IN ORDERING POWER AND KNOW THE REQUIREMENTS OF YOUR EQUIPMENT. INSUFFICIENT WATTAGE WILL RESULT IN BLOWN FUSES. ADDITIONAL CHARGES WILL BE MADE FOR CHANGES OR ADDITIONS.
2. LABOR FOR ELECTRICAL WORK MUST BE HANDLED BY CIVIC CENTER TECHNICIANS.
3. ALL EQUIPMENT, REGARDLESS OF POWER SOURCE, MUST COMPLY WITH ALL FEDERAL, STATE, AND LOCAL SAFETY CODES. THE CHARLESTON CIVIC CENTER RESERVES THE RIGHT TO REFUSE ELECTRICAL CONNECTION OF EQUIPMENT BASED ON SAFETY
4. ALL EQUIPMENT MUST BE PROPERLY TAGGED AND WIRED WITH COMPLETE INFORMATION AS TO TYPE OF CURRENT, VOLTAGE, PHASE, CYCLE, HORSEPOWER, ETC.
5. ALL MATERIAL AND EQUIPMENT FURNISHED BY CHARLESTON CIVIC CENTER FOR THIS SERVICE SHALL REMAIN THE PROPERTY OF CHARLESTON CIVIC CENTER. MATERIALS DAMAGED OR MISSING WILL BE BILLED TO THE EXHIBITOR.
6. ALL EXHIBITORS' CORDS MUST BE THE 3-WIRED GROUNDED TYPE. ALL EXPOSED NON-CURRENT CARRYING METAL PARTS OF FIXED EQUIPMENT WHICH ARE LIKELY TO BE ENERGIZED SHALL BE GROUNDED.
7. RATES QUOTED FOR ALL CONNECTIONS COVER ONLY THE BRINGING OF SERVICE TO REAR OF BOOTH IN THE MOST CONVENIENT MANNER.
8. WALL, COLUMN AND PERMANENT BUILDING UTILITY OUTLETS ARE NOT A PART OF BOOTH SPACE AND ARE NOT TO BE USED BY EXHIBITORS.

11. PAYMENT IS IN THE FORM OF CREDIT CARD INFORMATION, CHECK OR MONEY ORDER THAT MUST ACCOMPANY SERVICE ORDERS. POWER WILL NOT BE INSTALLED UNTIL PAYMENT IS RECEIVED.
