Opening Speaker: Jean Floten



Dr. Jean Floten Chancellor WGU Washington

Jean Floten became the first chancellor of WGU Washington in 2011. Having dedicated her career to postsecondary education, Chancellor Floten was drawn to the university's mission of expanding access to affordable higher education for all Washington residents. Under her leadership, WGU Washington has grown to more than 7,300 students and awarded more than 3,300 bachelor's and master's degrees.

Created by the Washington legislature through a partnership with Western Governors University, WGU Washington offers online, competency-based bachelor's and master's degree programs in more than 50 high-demand, career-oriented fields.

Chancellor Floten joined WGU Washington after leading Washington's Bellevue College for more than 22 years, where she developed the college from Bellevue Community College into an innovative, nationally acclaimed institution. Recognized as a leader in higher education, she is often asked to speak throughout the state and nation on technology education, funding, innovations in teaching, diversity,

student access, and other education issues. Prior to coming to Bellevue College, Mrs. Floten was Executive Vice President at Edmonds Community College in Lynnwood, Washington, where she served previously as Dean of Student Services and Director of Student Programs. Mrs. Floten serves on the national community college advisory board of Educational Testing Service and has served as a member of the Board of Directors of the Bellevue Chamber of Commerce and the Key Bank Advisory Board. She was awarded an Honorary Doctor of Letters by City University in 2006 and earned Master of Science and Bachelor of Arts degrees from Portland State University.

Track Overviews

SP

Strategy and Planning Track (Centennial E - First Floor)

Any college developing a CBE program will need strong and informed leadership. The sessions in this track will focus on topics like finance, and the use of data, as well as the evolving issues around accreditation, financial aid and federal policies.

Recommended for: executive staff, chief academic officers, business officers, deans, institutional research leaders. campus administrators

SE

Student Experience Track (Private Dining Room - First Floor)

Holistic, proactive student support is a critical factor for the success of the CBE students. In this track you can learn from best practices of innovative, advanced student support models used in competency-based education. All aspects of the student experience will be explored in-depth, from admissions to job placement, along with strategies for leveraging technology and data analytics in the race to accelerate student success.

Recommended for: student affairs personnel, IT, institutional research

Curriculum and Course Development Track (Centennial F - First Floor)

This track will explore an array of proven and promising practices to align curriculum and courses with state and industry competencies. Learn how CBE pioneers have developed courses, managed learning resources, and tackled tough challenges like course policy, and variable classroom paces among students. Sample courses will also be demonstrated.

Program Delivery Track (Spruce - Garden Level)

Flexible program and course delivery within existing college systems requires creative thinking and careful planning. Sessions in this track will reflect various models of CBE program delivery, from fully online to hybrid models. Participants will learn strategies to engage college stakeholders in flexible delivery systems, as well as tips for starting the conversation on faculty roles in a new delivery system.

Employer and Workforce Track (Spruce - Garden Level)

Employers are one of the most critical components to building effective CBE programs. Learn successful strategies of employer-CBE program partnerships. From understanding employer demand and increasing engagement, to improving opportunities for graduates, participants will be immersed in a diverse offering of employer and workforce best practices.
