#### Housing – What Will It Take to Build 30,000 Units Each Year? Room E141-144

#### Exploring Place-Based Models for Community Transformation: Room E145-146

This session will highlight promising place-based initiatives across the state that are aligning resources locally to improve outcomes. The Blue Zones Project Klamath Falls, pioneered by Oregon Healthiest State, will be highlighted along with other models of local transformation. Originally conceived as part of the Oregon Business Plan health care strategy to create conditions to improve the health of community members, the Klamath Falls project has led to a structure and process to address a wide array of opportunities in this community including education and upward mobility. We will discuss how Blue Zones Project and other models can lead to stronger, more resilient communities – and explore how a new partnership with Raj Chetty's Opportunity Insights initiative might strengthen such community collaborative initiatives.
