John Sibley Butler

Director

IC² Institute

John Sibley Butler holds the Gale Chair in Entrepreneurship and Small Business in the Graduate School of Business (Department of Management). He is the Director of the Herb Kelleher Center for Entrepreneurship and the Director of the Institute for Innovation, Creativity and Capital (IC²). Butler has taught M.B.A. programs in Mexico and Japan.

He was one of the distinguished professors selected for the election committee advisory board for then Texas Governor George W. Bush in 2000. In 2006, Butler was appointed by President Bush to the J. William Fulbright Scholarship Board. He was reappointed in 2007.

His research is in the areas of organizational behavior and new venture development. For the last eight summers, Professor Butler has occupied the Distinguished Visiting Professor position at Aoyama Gakuin University in Tokyo Japan, and this year holds the same status at Peking University in China.

Professor Butler has served as a consultant for many firms and the U.S. Military. At this time he is Management Consultant for State Farm Insurance Companies, with corporate headquarters in Bloomington, Illinois. His books and monographs include *Framework for Research on Leadership, Cohesion, and Values; Entrepreneurship and Self-Help Among Black Americans: A Reconsideration of Race and Economics; All That We Can Be: Black Leadership and Racial Integration the Army Way (with Charles C. Moskos - winner of the Washington Monthly Best Book Award); and <i>Immigrant and Minority Entrepreneurship: The Continuous Rebirth of American Communities* (with George Kozmetsky, forthcoming).

Professor Butler received his undergraduate education from Louisiana State University in Baton Rouge and the Ph.D. from Northwestern University in Evanston, Illinois. He is a decorated Vietnam Veteran.

WILLIAM BECKETT

Mr. Beckett is President and Chief Executive Officer of Chrysalis Packaging & Assembly Corporation, dba "CHRYSPAC". CHRYSPAC provides custom packaging, assembly, quality inspection, sorting, kitting, warehousing and fulfillment services to commercial and manufacturing businesses in the mid-west. CHRYSPAC employs over 25 workers in Milwaukee, WI. He has over 37 years of experience, including venture capital, banking and small business development. For 16 years as President of Chrysalis Capital Management, LLC, Mr. Beckett managed Future Value Ventures, Inc., a venture capital fund that invested in expanding early-stage



businesses owned by minorities and women. As the fund's President and Chief Executive Officer, Mr. Beckett raised and invested nearly \$8 million for 12 small businesses, including \$2 million of the fund's own capital, and syndicated an additional \$6 million from outside private and public institutions, individuals and venture funds. The fund invested in several notable businesses such as, ProStaff Personnel Services Corp., Sensor Devices, Inc., Manny's Products, Inc., Emerge Magazine, and THINK Innovative Media Services, Inc.

Following the "wind-up" of the fund in December 2000, Mr. Beckett embarked upon a new venture, CHRYSPAC, which acquired a two-year old packaging company, on August 1, 2001.

In addition to being an entrepreneur and former venture capitalist, Mr. Beckett was also very involved in Economic Development. In 1980, he was hired on as the first Executive Director of the Minority Business Development Program by the Wisconsin Business Development which later became Department of Commerce. In his five years tenure as director, he restructured the services and obtained legislative approval for 100% State funding of a new Bureau of Minority Business Development that started certifying minorityowned firms, established standards for certification and published the first annual Directory of Minority Business. The bureau created a no-fee service for locating businesses for sale, identified a group of financially (minimum \$50k to invest) and managerially (corporate business experience) qualified potential minority buyers, helped prepare business plans, raise venture capital and bank financing for several companies. The bureau organized and raised \$1.2 million in private capital from 22 major Wisconsin companies for an SBA regulated minority venture capital fund initially called The Wisconsin MESBIC, subsequently renamed Future Value Ventures.

Mr. Beckett's past includes, Manager for Wisconsin Power and Light Company in Madison, Wisconsin; Assistant Branch Manager for Wells Fargo Bank in San Francisco, California; and also Associate Director for Program Planning and Development at the Bay Area Urban League, in San Francisco. A service disabled veteran, he was a 1st Lieutenant and Assistant Adjutant in the US Army Adjutant General's Corps from 1967 to 1969 which included duty with Saigon Support Command of the 1st Logistical Support Battalion in the Republic of Viet Nam.






