COMMUNITY ECONOMIC DEVELOPMENT AWARD URBAN AND RURAL AGRICULTURE



GROWING POWER

Will Allen is an urban farmer who is transforming the planning, cultivation, production and delivery of good, healthy food to urban and rural populations. As the son of a southern sharecropper and former professional basketball player, ex-corporate sales leader and longtime farmer, he is recognized as a national/international leader in urban and rural agriculture and food policy. After a career in professional basketball and a number of years in corporate sales and marketing at Procter & Gamble, in 1993 he returned to his roots as a farmer to purchase the last remaining registered farm in the City of Milwaukee. Here he established Growing Power which has become a preeminent urban farm and non-profit organization.

In 2008, Allen was a John D. and Katherine T. MacArthur Foundation Fellow and "genius grant" winner. In 2010, Time Magazine named

Allen to its' list of 100 World's Most Influential People. A member of the Clinton Global Initiative, he was invited to the White House to join First Lady Michelle Obama in launching "Let's Move! "– her signature leadership program to reverse the epidemic of childhood obesity in America. In 2010, Allen received the Key to the City of Milwaukee, presented by Milwaukee Mayor, Tom Barrett. In 2011, Allen received The James Beard Award. In 2015, he was selected to the National Organic Standards Boards' Hydroponic/Aquaponic USDA Taskforce. Allen also attended the 2015 Milan Expo in Italy as part of the U.S. Presidential Delegation led by First Lady Michelle Obama. Allen has been named one of the World's Most Powerful Foodies by Michael Pollan and Forbes Magazine. He has also been given the National Education Association Security Benefit Corporation Award for Outstanding Service to Public Education in recognition of his work with children, teachers and schools.

Allen's autobiography, The Good Food Revolution: Growing Healthy Food, People, and Communities, was published in 2012 and received the Silver Medalist Award from Axiom Business Books. The book was nominated for Outstanding Literary Work for a NAACP Image Award in 2013. The Good Food Revolution is being used as a college text book across the nation.

In the world of basketball and sports, Allen was given the highest honor bestowed to a collegiate athlete, the Theodore Roosevelt Award from the National College Athletic Association with his name enshrined at the NCAA Hall of Champions in Indianapolis, Indiana. In 2012, he was also inducted into the Atlantic Coast Basketball Conference Hall of Legends. A member of the University of Miami Hall of Fame in 2010, Allen has been bestowed five honorary doctorates from the Milwaukee Institute of Art and Design, Marquette University, University of Wisconsin-Milwaukee, School of Freshwater Sciences, University of Miami, Florida and Hofstra University, New York.

YOUTH ENTREPRENEURSHIP

ReDonna Rodgers - CENTER FOR TEACHING ENTREPRENEURSHIP

Those visiting ReDonna Rodgers' office are greeted by a plaque reading, "Welcome to the department of sunshine and rainbows where hopes and spirits are lifted".

For 25 years, ReDonna Rogers, co-founder and executive director of the Center for Teaching Entrepreneurship (CTE), has worked with inner-city youth, providing an environment where dreams were nurtured, life skills taught, success principles discussed, accomplishments celebrated, and believes built. Over the years, CTE has touched more than 20,000 young people in the community.

CTE provides a vehicle for young people to explore, be challenged and not only find their way but to make their way. Those who know ReDonna have heard her words of wisdom many times and are examples of

the principles incorporated in CTE teachings such as: "You can't expect a forty-dollar job with a four-dollar education and a two-dollar attitude", "Invest in the best and the best is you", "Be a maker, not a taker", "The more you learn, the more you earn", and "If you can't get a job, create a job".

Over the years, CTE has been recognized by the Small Business Administration, Manhattan Institute Social Entrepreneurship, National Black Child Development Institute, YMCA, Business Journal Women of Influence Mentor Award and the Young Professional Intergeneration Award. ReDonna has been featured in the Black Enterprise Magazine, PBS "Reclaiming Our Neighbors", and Time Magazine.

ReDonna has contributed generously to the Fellowship Open, Milwaukee Urban League, Professional Dimension, Governor's Conference on Minority Business Development and the African American Leadership Project.

INVESTING AND SUPPORTING LOCAL COMMUNITIES

Bay Bank, Green Bay, Wisconsin



Bay Bank is a state chartered community bank based in Green Bay, Wisconsin. Bay Bank is owned and operated by the Oneida Nation and is one of only 18 tribally owned banks in the country. The bank is committed to economic and community development efforts in both the Green Bay area and the tribal communities of Wisconsin. Over the past two years, the bank has originated over 200 residential mortgages to Native American borrowers. In the past year, the bank has been the sponsor of \$1.7 million of Affordable Housing Program grants funded through the Federal Home Loan Bank of Chicago. As a result, three Wisconsin tribal communities have received or will receive \$1.7 million of

grant funding for their new housing projects. This year the bank provided two large construction loans for the building of 20 new single family homes as well as a new 24-unit apartment building on a reservation in northern Wisconsin and as a result increased that community's available housing stock by 44 units. The bank is a very active participant in the Low Income Housing Tax Credit space. Recently, the bank participated in the sponsorship of flood relief grants for residents of the Bad River reservation who were impacted by this summer's floods.

Bay Bank's recent consumer lending efforts include almost 1,200 personal loans to consumers for the purchase of a used vehicle or the payment of personal expenses. Over 90 percent of these customers are Native Americans. Over the past 2 years, the bank has also provided loans to small businesses on the Menominee Reservation, which is the only Wisconsin county that does not have a bank branch.

Bay Bank has assets of \$85 million and has two banking offices. The bank is profitable and well capitalized. It employs 27 people, including several tribal members. Bay Bank has a six-member Board of Directors, of which five are members of federally recognized Tribes. Its President and CEO Jeff Bowman is a tribal member of the Stockbridge-Munsee Band of Mohican Indians.
