60x30TX Strategic Plan - Goals

1. 60x30: EDUCATED POPULATION

By 2030, at least 60 percent of Texans ages 25-34 will have a certificate or degree

2. COMPLETION

By 2030, at least 550,000 students in that year will complete a certificate, associate, bachelor's, or master's from an institution of higher education in Texas

3. MARKETABLE SKILLS

By 2030, all graduates from Texas public institutions of higher education will have completed programs with identified marketable skills

4. STUDENT DEBT

By 2030, undergraduate student loan debt will not exceed 60 percent of first-year wages for graduates of Texas public institutions

Methodology

Literature review

Solicited feedback from stakeholders

- ► Faculty and staff from public institutions of higher education
- ► State agencies
- ► Textbook publishers
- ► Representatives of the OER community
- **►** Others



Report Recommendations

- 1. Develop an open statewide OER portal
- 2. Work with OER Commons to develop and maintain the portal
- 3. Ensure that the portal links to repositories using a wide range of OER
- 4. Incentivize faculty to adopt, contribute, and submit reviews through the portal
- 5. Require that resources developed with state funds be contributed to portal and Creative Commons licensed
- 6. Long-term integrated portal and resource awareness program
- Create a statewide OER council
- 8. Fund a new position of state Director/Coordinator of OER



SB 810 Open Educational Resources Grant Program (OERGP)



About the OER Grant Program

Established to encourage faculty at institutions of higher education to adopt, modify, redesign, or develop courses that use only open educational resources (OER).

Open Educational Resource – A teaching, learning, or research resource that is in the public domain or has been released under an intellectual property license that permits the free use, adaptation, and redistribution of the resource by any person.

Texas Education Code (TEC), Section 61.0668



Grant Awards

Maximum of \$8,000 for applications that proposed to adopt, modify, redesign, or create **one course** that will use only open educational materials and a maximum of \$16,000 for applications that proposed to adopt, modify, redesign, or create **multiple courses**.

Grants distributed directly to faculty.



Application Timeline

Application deadline: August 20, 2018

41 eligible applications received.

Announcement of Grant Awards: October 30, 2018

15 applications selected for grants.



HB 3652 State Repository for OER




OER Repository

THECB will contract with an existing educational resource repository to develop and maintain a web portal for OER.

Portal will be searchable by course or learning outcome, program or field of study, marketable skills, college readiness, and other topics as determined by THECB.

To be completed by September 1, 2020.

A collaborative effort between DigiTex, THECB, and ISKME to assess the OER programs, policies, and practices already underway across Texas, toward enabling OER as a state-wide strategy for meeting the goals of 60x30TX.








Key Research Questions


- 1. How and to what extent are institutions across Texas using OER?
- 2. What challenges and incentives are affecting OER adoption?
- 3. What supports enable increased adoption and use of OER?
- 4. Where is the most promise, in terms of the use and impact of OER within and across institutions?

Survey administered in May 2019 to all 158 twoand four-year public and private institutions



Survey targeted to OER-knowledgeable people on campus





Key Findings


There is a growing commitment to OER across Texas

Institutions with OER programs or policies in place (N=99)




OER-based courses are prevalent and likely to scale

Percentage of undergraduate courses that are fully OER-based (N=96)




Yet, explicit open licensing policies in support of OER are limited

Institutions that have an open licensing policy (N=100)



And many institutions lack a written definition of OER to guide their work

Institutions that have a written definition of OER (N=100)




The majority of institutions have implemented the state's course marking requirement (SB 810)

Implementation of course marking requirement (N=96)

Listed as OER through the campus bookstore	41%
Notation/description provided under the individual course listing	29%
OER search field provided on the course schedule landing page	9%
Links to all OER courses provided on the landing page	7%
OER search field provided on subsequent pages (not on the landing page)	4%
Other	4%
Not applicable, not yet implemented	39%


Although, terms used to mark courses vary, and several institutions do not use the term "OER"

Terms used to mark OER courses in course schedules or listings (N=50)




Library staff play an important role in enabling OER





Libraries also serve as a key source of funding for OER



Analysis of institutions leading the way in OER reveal best practices

Looking across institutions that have <u>both</u> policies and programs in support of OER (n=9) revealed that they tend to:

- Have a centralized OER committee/office
- Allocate funding to OER, and prioritize funding for faculty use of OER
- Offer faculty incentives to encourage use of OER
- Have library staff who are trained on OER
- Collect data on the impact of OER

Key implications from the survey center on operational supports that will enable institutions to...

- Create standardized language and definitions around OER;
- Develop formal policies in support of OER programs, including language that specifies open licensing within intellectual property guidelines and employment contracts;
- Identify new, external sources of funding for their OER work
- Develop or identify effective OER training and incentive programs for faculty; and
- Curate OER to expand the range of course subjects, particularly in career and technical education, for which OER are available and can support full, zerotextbook cost credentials in these fields.
