The team will discuss the progress over the last week of each participant to be seen later that day in court, deciding what incentives will be offered for positive behaviours and what sanctions will be applied for negative conduct. Attendees will then watch the magistrate review each defendant.</i>
	NICHOLSON HOUSE <i>Nicholson Program is a state-wide Specialist Forensic Disability Accommodation (SFDA) service that offers specialist support to people with an intellectual disability who are involved in the criminal justice system. The Site Tour will include a presentation and guided visit of the entire program, including the intensive and semi-independent areas of the program, the in-house training kitchen and the training/program room.</i>

SITE TOUR TWO 10.00am – 2.00pm	JUDY LAZARUS TRANSITION CENTRE (JLTC) <i>The Judy Lazarus Transition Centre took its first prisoners on 30 April 2007, having been officially opened on 20 April 2007. The Centre provides a supervised pathway back into society for selected prisoners nearing the end of their sentence.</i>
	THOMAS EMBLING HOSPITAL <i>The Thomas Embling Hospital is a secure, forensic mental health hospital operated by the Victorian Institute of Forensic Mental Health (Forensicare). The hospital currently has 124-beds operating and is located adjacent to extensive parklands in suburban Melbourne. The tour will include a guided walk around the campus and overview of the hospital and the broader service.</i>

SITE TOUR THREE 12.00pm – 5.00pm	KARREENGA PRISON – BAKERY <i>Karreenga due to open soon, will have a strong focus on rehabilitating prisoners and improving their employment prospects once they complete their sentence. The bakery will supply bread, pastries and pies to prisons around the state, employing and training up to 60 prisoners per shift.</i>
	BARWON PRISON - PIPER DETENTION UNIT <i>Piper Detention Unit (Piper) is planned to house up to 10 offenders who have completed their sentence but are subject to a court-imposed detention order because they present an unacceptable risk of re-offending.</i>
