RE: USW District 2 Health and Safety Training

Dear Sisters and Brothers:

USW District 2 is pleased to announce that **Health and Safety Training** has been scheduled for Wednesday, May 4 and Thursday, May 5, 2016 at the **Hyatt Regency Hotel** in Milwaukee, Wisconsin.

Registration will be held on Wednesday, May 4 from 8:00 a.m. to 8:45 a.m. Both classes will begin promptly at 9:00 a.m. and conclude at approximately 5:00 p.m. Please note that there are two separate Health & Safety training sessions and they run concurrently. Therefore, you must indicate on the registration form whether you will be attending Session A or Session B.

Session A: Incident Investigation (2-days)

For health & safety committee members, and workers involved in incident and near-miss investigations at their facilities.

Incident Investigation (Days 1 & 2):

This 16-hour course uses activities to introduce and demonstrate systems of safety as a vehicle to apply fixes to root causes. Class activities allow participants to be a part of an investigation team in identifying root causes using logic tree analysis. Participants will use sample incidents and/or near-miss incidents from their workplace, practice their skills as they learn to identify root causes of incidents and recommend solutions to control the hazards.

Session B: Near-Miss and History of an Incident (2-days)

For local union officers, union health & safety representatives and committee members.

Near-Miss (Day 1):

This course prepares workers to lead and/or play an important role in a worker-developed and led Near-Miss Program. This is achieved with incident investigation techniques, which produce important fixes to hazards identified during the investigation of a particular incident. The goal is to prevent incidents and near-miss actions in the future.

History of an Incident (Day 2):

To use a new type of mapping to explore past events and how missed opportunities for fixing past incidents can contribute to a catastrophic event. To examine your own experiences with hazards, nearmisses, incidents or other issues that represent missed opportunities to improve health and safety in your workplace.
