The 2011 Laureates will be recognized publicly at the Laureate Medal Ceremony and Gala Evening on June 20<sup>th</sup> in Washington D.C. During this ceremony, case studies are formally inducted into the program's International Archives, and honorees are presented with a medallion inscribed with the Program's mission, "A Search for New Heroes."

At the Gala Evening, additional honors are given to 55 21<sup>st</sup> Century Achievement Award finalists— five Laureates from each of the eleven categories—each with a Case Study selected by Program Judges to represent outstanding innovation within the information technology field. That field is narrowed further with the presentation of the 21st Century Achievement Awards. These awards are given to only one Finalist in each category, singled out for special recognition by the Program Judges to be the very best among their peers.
