JENNIFER AUGUST

Jennifer August is Counsel with the Constitutional Law Branch. Jennifer received her LL.B. from the University of Toronto. She articled with the Constitutional Law Branch and was called to the Bar in 1997. Jennifer has worked as Litigation Counsel at the federal Department of Justice, where she practised in the areas of aboriginal and public law. Jennifer has also worked as Counsel at the legal clinic ARCH, where she conducted disability rights test case litigation. At the Constitutional Law Branch, Jennifer has an advisory practice, which often focuses on federal/provincial division of powers issues. Along with Janet Minor and Zachary Green, she was Counsel for Ontario on the province's intervention in the federal Securities Reference at the Supreme Court of Canada.

ROBIN K. BASU

Robin K. Basu (B.A., 1988; LL.B., 1990, University of Toronto) is Counsel in the Constitutional Law Branch of the Ontario Ministry of the Attorney General. He was called to the Bar in 1992 and practised with the Toronto litigation boutique Genest Murray DesBrisay Lamek in both private and public law. In 1999, he founded Basu Morris, continuing the practice of civil and commercial litigation until he joined the Ontario Government in 2003. His government practice consists of constitutional and human rights litigation, and opinion work for government on constitutional and human rights issues.

Robin's work has included the successful defence from first instance onwards of the *Charter* challenge to the exclusion of farming from the *Labour Relations Act* (*Fraser v. Ontario*, 2011); the successful constitutional defence from the lower courts through to the Supreme Court of the first provincial civil forfeiture statute directed at proceeds of crime (*A.G. v. Chatterjee*, 2009) and several significant appellate decisions on the interpretation that statute; discrimination claims involving social, medical and educational benefits; and *habeas corpus* claims by persons incarcerated on terrorism charges.

He is currently defending a s. 2(d) *Charter* challenge by the Ontario Medical Association in connection with the government's measures to implement the 2012 Budget (*OMA v. Ontario*); ss. 7 and 15 *Charter* litigation brought by Ecojustice in connection with alleged environmental harms in Sarnia (*Lockridge v. Ontario*); and an appeal to the Court of Appeal of s. 8 *Charter* challenges made by physicians facing professional discipline (*Sazant v. CPSO*).

Robin has acted as Lead Counsel on Ontario's interventions in notable cases at the Supreme Court, including *BC Health Services* (ss. 2(d) and 15), *Canadian Western Bank* (federalism), *JTI-MacDonald* (s. 2(b)), *Imperial Tobacco* (unwritten constitutional principles), *Rothmans* (paramountcy) and *Tessier* (federal vs. provincial labour jurisdiction).

He has served as Course Director for Advanced Civil Advocacy at the Ministry of the Attorney General's Crown Counsel Summer School.

Robin has presented and published on both constitutional and private law issues.

THE HONOURABLE ROBERT N. BEAUDOIN

B.A. 1970, (Windsor); M.Ed. 1974 (U of T); LLB 1979, (Windsor). Justice Beaudoin was called to the Bar (Ontario) in 1981. He initially practiced Family Law in Windsor where he was also a part-time assistant

Crown Attorney. In 1989 he was appointed the Regional Director of Courts Administration for East Region in Ottawa. He joined the Civil Justice Review in 1994 and later became the Project Director. He participated in the productions of the Review's two reports aimed at reforming Ontario's civil justice system. He has extensive experience in civil case management and court-annexed mediation. In January of 1997, he was appointed the Case Management Master for the Superior Court of Justice in Ottawa. After his appointment, he was involved in lecturing and providing advice on the topics of case management and mediation to interested groups in Canada and abroad. He has participated in a number of international justice projects in the Caribbean, Asia and Africa. In 2007, he was named one of two Family Case Managers involved in a Pilot Project in the Family Branch of the Superior Court in Ottawa. He was appointed a judge of the Superior Court of Justice in September, 2009.

SARA BLAKE

Sara Blake is the author of the leading text, *Administrative Law in Canada* (LexisNexis), now in its fourth edition. She is frequently invited to speak on the subject of Administrative Law.

Since 1997, Sara has been practising general civil litigation. She is employed by the Ontario Ministry of the Attorney General, Crown Law Office – Civil, where she acts for government ministries and agencies in appeals, civil actions and on applications for judicial review and tribunal hearings. She has argued cases before all levels of court, including the Supreme Court of Canada, the Ontario Court of Appeal and the Federal Court of Appeal. Previously, she was Senior Litigation Counsel at the Ontario Securities Commission where she conducted numerous investigations and proceedings before the Commission and the courts.

Sara is a recipient of the 2009 SOAR Medal, awarded by the Society of Ontario Adjudicators and Regulators to recognize an outstanding contribution to the administrative justice system in Ontario. She served on the Electronic Discovery Subcommittee chaired by Justice Colin Campbell. She served as a member of the SOAR Model Rules Committee who drafted model procedural rules for all Ontario tribunals. She attended Osgoode Hall Law School and was called to the Bar in Ontario in 1985.

PARMINDER K. BRAR

Parminder K. Brar is Counsel with the Legal Services Branch for the Ministry of Education and the Ministry of Training, Colleges and Universities. She received her LL.B. and M.A. from the University of Toronto and also studied at the University of New South Wales in Sydney, Australia. She has been with the Ministry of Education since 2009, and has been involved in the Safe Schools portfolio since 2010. She was involved in the development and drafting of Bill 13, (*The Accepting Schools Act, 2012*). Parminder's previous experience with the Ministry of the Attorney General includes acting as Counsel for the Civil Remedies for Illicit Activities Office, and as a policy analyst for the Ministry's Hate Crimes Working Group.

WILLIAM BROMM

William Bromm has been in the Ontario Public Service for 22 years, the last 12 with the Ministry of the Attorney General. He served as Legal Counsel and Executive Assistant to former Deputy Attorney General Murray Segal, and has been Legal Counsel to three Secretaries of the Cabinet. In 2011, William joined the office of former Secretary of the Cabinet Shelly Jamieson to assist with a number of special projects, including planning for the 2011 general election. He is currently continuing his temporary assignment with Cabinet Office.

MICHAEL BRYANT

Michael Bryant is a lawyer, teacher, dad, author and former Cabinet Minister. He is a Principal at Iskonigan Inc., with former National Chief of the Assembly of First Nations, Phil Fontaine. He is also a Lecturer and a Fellow at the University of Toronto, and authored the Globe & Mail #1 bestseller, 28 Seconds, his memoir, published by Penguin. Bryant was the youngest Attorney General in the history of Ontario, and served as Minister of Economic Development, Minister of Aboriginal Affair, and Government House Leader in the Ontario Government, between 2003 and 2009. Elected at the age of 33, Bryant was the Member of Provincial Parliament for the mid-town Toronto riding of St. Paul's for a decade. Previously, Bryant was a commercial litigator at McCarthy Tetrault LLP, and after politics served as a Senior Advisor at the global law firm Norton Rose, LLP. He was a Lecturer in Law at King's College, University of London, and an adjunct professor at University of Toronto and Osgoode Hall Law School. He clerked at the Supreme Court of Canada, for the present Chief Justice of Canada, in 1992/93. A Fulbright Fellow at Harvard Law School, Bryant was also educated at UBC and Osgoode Hall Law School. He resides in Toronto with his two young children.

GARY M. CAPLAN

Gary M. Caplan is a partner in the Toronto law firm of McCague Borlack LLP where he practices civil litigation and ADR. He is certified by the Law Society of Upper Canada as a Specialist in Civil Litigation. He also holds the designations of Chartered Mediator and Chartered Arbitrator from the ADR Institute of Canada. He has a Diploma in International Commercial Arbitration granted by the Chartered Institute of Arbitrators, London, England and is an associate member of the Institute.

Gary's litigation practice areas include employment, professional errors and omissions, and discipline, and a wide range of commercial and insurance (defence and subrogation) matters.

Gary obtained his B.A. from McGill University and in 1974 was a Parliamentary Internship Scholar at the House of Commons in Ottawa. He was granted his LL.B. from University of Toronto in 1978 and was called to the Bar in 1980. Gary was granted an LL.M. in Constitutional Law in 1990 and an LL.M. in ADR in 1998, both from Osgoode Hall Law School. He was appointed adjunct Professor of Law at that school where he has taught both Civil Procedure and Dispute Resolution. Gary was a Sessional Lecturer in Civil Procedure at Queen's University, Faculty of Law in Kingston Ontario in 2009. Gary is presently an Adjunct Professor of Law at University of Toronto Law School, where he teaches "Introduction to the Theory and Practice of Mediation". Gary is a frequent speaker and training coach for the Advocates Society and other professional bodies. He was selected by his peers to be included in the 2009, 2010, 2011, and 2012 edition of The Best Lawyers in Canada in the specialty of Alternative Dispute Resolution.

RONALD CARR

Ronald Carr has practised in the field of commercial litigation since 1974. He has appeared at all levels of Court and Tribunals including the Superior Court of Ontario, the Court of Appeal for Ontario and the Supreme Court of Canada, as well as various tribunals including the Ontario Securities Commission, the Institute of Chartered Accountants of Ontario, the Canadian Institute of Actuaries, the Ontario Municipal Board and the Law Society of Upper Canada. He has also appeared in proceedings in other jurisdictions including British Columbia, Nova Scotia, New York, Texas and California. After 32 years in the private sector, Ronald joined the Ministry of the Attorney General, Crown Law Office – Civil in January 2006 to assist it in the handling of complex commercial disputes in which the Government of Ontario is a party. Since that date, Ronald has been involved in a wide range of matters on behalf of various ministries of

the Crown and is currently Senior Counsel on the action brought by the Province of Ontario against the tobacco industry to recover health care expenses incurred in the treatment of tobacco-related diseases.

SHANNON CHACE

Shannon Chace has an LL.B. from Queen's University and was called to the Bar in Ontario in 2002. Shannon has been Counsel with the Constitutional Law Branch since 2004 and has represented the province in constitutional cases before all levels of court in Ontario and before the Supreme Court of Canada. Shannon was Co-Counsel in the defence from first instance onwards of s. 2(d) and s. 15 *Charter* challenges to the exclusion of farming from the Labour Relations Act (*Fraser v. Ontario*), which was decided favourably by the Supreme Court of Canada in a landmark judgment released in April, 2011. Prior to coming to the Constitutional Law Branch, Shannon clerked for Justice Louis LeBel of the Supreme Court of Canada and practised civil litigation at Torys LLP. Shannon has an M.A. in English Literature from Queen's University and is currently pursuing an M.Ed. in Counselling Psychology from OISE at the University of Toronto (part-time).

MONIQUE CHARLEBOIS

After a few years in private practice in Montreal, Monique Charlebois worked for eight years as a senior manager in a variety of policy branches or legislative implementation projects at the federal government and in the OPS. She joined the Office of the Public Guardian and Trustee in 1994, first as Estates team leader managing a diverse staff of 8-10, and since 2000 as Estates Counsel primarily doing solicitor work.

Monique was instrumental in laying the groundwork for the first French-language public elementary school in Oakville which opened in 1998 and was later appointed to a term on the Special Education Tribunal (French Language). Monique is currently ALOC's Vice-President for Planning and Development.

ROBERT E. CHARNEY

Robert E. Charney is General Counsel with the Constitutional Law Branch of the Ontario Ministry of the Attorney General. He received his LL.B. in 1981 from the University of Windsor and his LL.M. in 1983 from Columbia University. He has been with the Ministry of the Attorney General since 1984, and has represented the Ministry in constitutional cases at all levels of court. He has advised the Ontario Government on constitutional issues, and has appeared as Counsel for the Ministry in the Supreme Court of Canada in cases, including Adler v. Ontario, M. v. H., Vreind v. Alberta, Eaton v. Brant County Board of Education, PIPS v. NWT, Cuddy Chicks v. OLRB, Lavigne v. OPSEU, Ontario v. Ontario English Catholic Teachers' Association, Auton v. British Columbia, Baier v. Alberta, Alberta v. Hutterian Brethren, Vancouver (City) v. Ward and Withler v. Canada. He is an Adjunct Professor at Osgoode Hall Law School, and has taught Constitutional Litigation at Osgoode Hall Law School, the University of Windsor, and the University of Haifa Law School.

LIEUTENANT-GENERAL THE HONOURABLE ROMÉO A. DALLAIRE

Lieutenant-General Roméo A. Dallaire was born in Denekamp, Holland, on 25 June 1946. He enrolled in the Canadian Army in 1964 after four years in the Cadets and the Reserves. He attended the Collège militaire royal de Saint-Jean and graduated with a Bachelor of Sciences in 1969 from the Royal Military College in Kingston, ON. He also attended the Canadian Land Forces Command and Staff College and

the United States Marine Corps Command and Staff College in Virginia. He is a Fellow of the Carr Centre for Human Rights Policy, the John F. Kennedy School of Government, Harvard University.

Promoted to the rank of Brigadier-General on 3 July 1989, he assumed command of the Collège militaire royal de Saint-Jean. After studying at the British Higher Command and Staff Course, Camberly, United Kingdom in the spring of 1991, he was appointed Commander 5e Groupe-brigade mécanisé du Canada at Valcartier on 5 July 1991. He left Valcartier on 1 July 1993 to take command of the United Nations Observer Mission - Uganda and Rwanda (UNOMUR) and the United Nations Assistance Mission for Rwanda (UNAMIR). He was awarded the Meritorious Service Cross in recognition of his exceptional leadership and professionalism.

He was promoted to the rank of Major-General on 1 January 1994. From September 1994 to October 1995, he assumed simultaneously the positions of Deputy Commander of Land Force Command in St. Hubert and Commander of the 1st Canadian Division. On 2 June 1995, the Canadian Conference of Defence Associations presented him with "The Vimy Award". On 20 October 1995, he assumed command of Land Force Quebec Area.

On 9 January 1996, he was awarded the Legion of Merit by the United States and on 2 July 1996, he assumed the position of Chief of Staff to the Assistant Deputy Minister (Personnel) Group. Promoted to Lieutenant-General, he assumed the duties of Assistant Deputy Minister (Human Resources-Military) in April 1998.

On 5 February 1999, Lieutenant-General Dallaire was appointed to the position of Special Advisor to the Chief of the Defence Staff for Officer Professional Development. His duties there dealt with matters regarding the Reform of the Officer Corps, including the General and Admiral Senior Executive branch, and its professional development into the future. He remained in this position until medically released from the Canadian Forces on 18 April 2000.

Her Excellency the Right Honourable Adrienne Clarkson, Governor General of Canada, on the advice of the Right Honourable Paul Martin, Prime Minister of Canada, summoned General Dallaire to the Senate on 24 March 2005.

He remains a Special Advisor to the Minister responsible for the Canadian International Development Agency on matters relating to War Affected Children around the world, as well as the Minister of Veterans Affairs Canada on matters relating to serving and retired members and their families. The United Nations appointed Lieutenant-General Dallaire to an Advisory Committee on Genocide Prevention. Since his release from the military, he has also worked to bring an understanding of post-traumatic stress disorder to the general public. He is a visiting lecturer to a number of Canadian and US universities and he has written several articles and papers on Conflict Resolution and Humanitarian Aid/Human Rights. He is also advisor to the Minister of National Defence on the professional development and the education of the members of the Canadian Force.

In 2010, he published his latest highly anticipated book, *They Fight Like Soldiers, They Die Like Children:* The Global Quest to Eradicate the Use of Child Soldiers in which Dallaire states: "The ultimate focus of the rest of my life is to eradicate the use of child soldiers and to eliminate even the thought of the use of children as instruments of war."

In 2003 he published *Shake Hands with the Devil – the failure of humanity in Rwanda* an internationally recognized bestselling book on the Rwanda genocide based on his experiences in and after the United Nations Mission to Rwanda in 1993-94. The book was awarded the Governor General's Literary award for Non-Fiction in 2004, and has garnered numerous international literacy awards. The book was released as a full-length feature film *Shake Hands With the Devil – The Journey of Roméo Dallaire* in the fall of 2007 and won the Emmy Award for Best Documentary in the same year.

While a Fellow of the Carr Centre for Human Rights Policy, John F. Kennedy School of Government at Harvard University, he pursued research on conflict resolution and the use of child soldiers. He is a Senior Fellow at Concordia in genocide research. General Dallaire has been named a Fellow of Ryerson Polytechnic and an Honorary Fellow of the Royal College of Physicians and Surgeons of Canada. He has also received numerous honorary doctorates from Canadian and American universities.

He is the first recipient of the Aegis Award on Genocide Prevention from the United Kingdom and was awarded the United Nations Association of Canada's Pearson Peace Medal, the Arthur Kroeger College Award for Ethics in Public Affairs by Carlton University, the Harvard University Humanist Award for 2005 and the Laureate of Excellence from the Manitoba Health Sciences Centre.

He was invested as an Officer of the Order of Canada in October 2002 by the Governor General of Canada and invested as a Grand Officer of the National Order of Québec in June 2005. He is a Commander of the Order of Military Merit. General Dallaire was appointed to the United Nations Secretary General's Advisory Committee on Genocide Prevention in the spring of 2006.

General Dallaire and his family live in Quebec City.

DANA DE SANTE

Dana De Sante was called to the Bar 1985. Dana began practicing with the Public Guardian and Trustee in 1989. He practises exclusively in the fields of wills, trusts, charities law and estate litigation. He is the author of various papers on charities matters and a frequent speaker on charitable law issues. Dana has numerous court decisions reported in the areas of estates, trusts and charities.

MARK ELLIS

Mark Ellis joined Baker & McKenzie's Toronto office in late 2002 after practicing for over 20 years at major Canadian law firms. He is one of Canada's leading advisers on fiduciary obligation, corporate governance and employment law. Mr. Ellis works closely with Baker & McKenzie practitioners throughout North America and around the globe to further enhance the Firm's renowned international labor and employment practice. Lise articled with the Crown Law Office – Civil in 1994-95, after which she practised in the area of litigation at Blake, Cassels & Graydon LLP for almost eight years. GARY LOGAN
